


5. To the best of the Trustee's knowledge and belief: AAC is disinterested as that term is defined in § 101(13) of the Bankruptcy Code, and holds no interest adverse to or in connection with the debtors, creditors of the estate, and any other party in interest or their respective attorneys and accountants. 6. Pursuant to Rule 2014 of the Federal Rules of Bankruptcy Procedure, this request may be made by application.

Upon these facts, the Trustee requests that this Court enter its Order authorizing employment of AAC to assist her or her attorneys in their duties described in 11 U.S.C. § 704(1), (2), and (4), and that she have such other and further relief as the Court deems just and equitable.


