APPLICATION FOR ORDER SHORTENING TIME  
OF NOTICE OF SALE PURSUANT TO § 363(b) and (f)

Comes now the Trustee, Janice D. Loyd, and respectfully prays the Court issue an Order Shortening the Notice Period for objections to the Trustee's Motion to Sell Property of the debtor estate to a period of ten (10) days from receipt of said notice.

In support of said Motion, the Trustee would advise the Court of the following:


1. On June 13, 2003, Trustee filed a Motion to Sell certain property of the debtor estate pursuant to 11 U.S.C. §363(b) and (f). Said property consists of live worms, castings, bedding materials and equipment located at the LAAP facility in Minden, Louisiana.

2. Due to the nature of the inventory involved, including approximately 300,000 lbs. of live worms which need to be fed and watered, it is necessary that the assets be sold as quickly as possible to insure that no further injury, loss, or damage will result to the worm inventory.

3. The Trustee therefore requests that the Court shorten the notice period for objections thereto to a period of ten (10) days from the receipt of said notice. No other requests to shorten notice have been made.

WHEREFORE, Janice D. Loyd, Trustee, respectfully prays the Court issue an Order shortening the Notice Period of the Trustee's Motion to Sell Property Pursuant

to 11 U.S.C. (b) and (f) to a period of ten (10) days from receipt of same and for such other and further relief as is just and equitable.


