

ORDER DENYING RESPONDENT'S MOTION TO STRIKE

On November 2, 2004, the Oklahoma Department of Securities (Department) commenced this action by the filing of the Enforcement Division's Recommendation (Initial Recommendation). On April 14, 2005, the Enforcement Division filed its Supplemental Recommendation.

On April 19, 2005, Respondent Benjamin Wei, by and through his counsel of record, filed a Motion to Strike the Enforcement Division's Supplemental Recommendation. The Department filed a response on April 25, 2005, and Respondent filed a reply on April 26, 2006 (Reply). The Reply included a request for the Administrator to order the Supplemental Recommendation removed from the Department's website.

IT IS HEREBY ORDERED that:

1. The Motion of Respondent to Strike the Enforcement Division's Supplemental Recommendation is hereby denied. The provisions of the Amended Scheduling Order issued March 29, 2005, remain in full force and effect to the extent that such matters are to occur on or after April 27, 2005; and
2. The Enforcement Division shall cause the Initial Recommendation and the Supplemental Recommendation to be removed from the Department's website.


