ORDER FOR RETURN OF FUNDS

This matter came on for hearing this 5 day of February, 2009, before the undersigned Judge of the District Court in and for Oklahoma County, State of Oklahoma, on the motion of the Oklahoma Department of Securities *ex rel.* Irving L. Faught, Administrator, (Plaintiff), and Relief Defendant Gerald Cooper (Relief Defendant), for an order authorizing a return of investment funds to Squicor, LLC. Plaintiff appears by and through its attorney, Patricia A. Labarthe. Relief Defendant appears by and through his attorney, Jerry Gunter. After considering the evidence, the Court finds that the return of investment funds to Squicor, LLC should be approved.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Squicor, LLC is entitled to a return of investment funds of Four Thousand Three Hundred Ninety-Four Dollars and Sixty-Five Cents (\$4,394.65), from account number 000000708316039 (Account) at JP Morgan Chase Bank.

IT IS FURTHER ORDERED that JP Morgan Chase Bank issue a cashier's check to Squicor LLC for the balance in the Account, and close the Account.

IT IS FURTHER ORDERED that JP Morgan Chase Bank mail the cashier's check to Squicor LLC, and provide a copy of the cashier's check to Plaintiff, no later than twenty (20) days from the date of this Order.
