DEFAULT JUDGMENT AGAINST DEFENDANT RICHARD D. MARTIN

This matter came on for hearing before the Court, Honorable District Judge Daniel L. Owens presiding, on the motion of Plaintiff for default judgment against Defendant Richard D. Martin ("Defendant Martin"), to be heard *instanter*, without notice, pursuant to Rule 10 of the Rules for District Courts of Oklahoma.

The Court, having reviewed the petition, summons, *Notice of Service on the Administrator and Affidavit of Compliance*, and court file, finds that Defendant Martin has been validly served with petition and summons, that the date by which Defendant Martin was required to appear and defend this action is April 16, 2007, and that no appearance has been made by Defendant Martin, nor has any motion or pleading been filed on his behalf.

Defendant Martin is in default and has thus admitted the substantial allegations of the petition. The Court, being fully advised in the premises, and on consideration thereof, finds that the allegations of Plaintiff's *Petition* are deemed true as therein set forth with respect to Defendant Martin, and that Plaintiff is entitled to a permanent injunction against Defendant Martin forever enjoining and restraining him from transacting business in or from the state of

Oklahoma as an issuer, issuer agent, broker-dealer, broker-dealer agent, investment adviser, and/or investment adviser representative.

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that Defendant Martin is forever enjoined and restrained from transacting business in or from the state of Oklahoma as an issuer, issuer agent, broker-dealer, broker-dealer agent, investment adviser, and/or investment adviser representative.

IT IS SO ORDERED.


1. That he is the Administrator of the Oklahoma Department of Securities (“Department”).

3. That the Administrator received service of process on behalf of Defendant Richard D. Martin, pursuant to Section 1-611 of the Act on March 26, 2007.




