AGREED ORDER

On August 29, 2008, this Court issued the *Temporary Injunction and Order Freezing Assets ("Order")* in this matter. The Order was supplemented by orders of the Court on September 9, 2008 and November 4, 2008. Based on the motion filed by Plaintiff on November 21, 2008, to further modify the Order, as supplemented, and the agreement of the parties hereto, the Court finds that the Order, as supplemented, should be further modified.

THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that, effective immediately, the Order as supplemented, be modified as follows:

- a. Defendant's expenditures relating to his rehabilitation and Mr. Welch's legal services shall be limited to those authorized in the Court's order of November 4, 2008;


- b. the term "ordinary, reasonable and/or recurring living expenses" shall be limited to: current mortgage payments; home/car/health/dental insurance premiums; utilities; emergency home maintenance services; income tax estimates; the payments to Sherry Cash pursuant to the Court's order from the hearing of December 19, 2008; medical care, and incidentals of Jerry Cash such as groceries and fuel;
- c. the incidentals of Jerry Cash referenced in paragraph b. above shall be limited to an amount of Two Thousand Five hundred Dollars (\$2,500) per month beginning on February 1, 2009;
- d. expenditures for the maintenance of the grounds around the home on Nichols Road shall be restricted to basic lawn care services and shall not exceed Twelve Hundred Dollars (\$1,200.00) per month;
- e. housekeeping expenditures for the home on Nichols Road shall not exceed Fourteen Hundred Dollars (\$1,400.00) per month; and
- f. the minimum required monthly payments shall be paid on the Capital One and Citi credit card debt and no further debt shall be incurred on these cards or on any other credit card held by Defendant other than charges for the incidentals referenced in paragraphs b and c above .

IT IS HEREBY FURTHER ORDERED, ADJUDGED AND DECREED that the services of Hiroshi Makita will be terminated by Defendant no later than February 15, 2009, and that the use of any automobile owned by Defendant and/or his spouse, and the continued occupation of the house located at 1612 Downing, Oklahoma City, Oklahoma,

by Hiroshi Makita be terminated as of February 28, 2009, unless Mr. Makita agrees to make monthly payments in the amount of \$600.


IT IS HEREBY FURTHER ORDERED, ADJUDGED AND DECREED that until otherwise ordered by the Court, Defendant's current accountant shall continue to perform accounting/bookkeeping services in connection with the deposit of any income received by, or payment of the business and authorized personal expenses of, Defendant in accordance with this Court's orders. The accountant shall also issue checks to Sherry Cash in accordance with the Court's order from the hearing of December 19, 2008. Defendant is ordered to provide the accountant with the checkbooks for all accounts held in the name, for the benefit, or under the control of Defendant.

IT IS HEREBY FURTHER ORDERED ADJUDGED AND DECREED the prior approval of the Court shall be required for any deviation from the Court's orders relating to the receipt of income or expenditures paid from any account subject to the Order, as supplemented.
