





**ORDER AUTHORIZING PAYMENT OF
INTERIM ATTORNEY FEES BY RECEIVER**

NOW on the 19th day of January, 2011, the Receiver's Application for Authority to Pay Interim Attorney Fees comes before the Court for consideration.

Based on the Receiver's Application, the Court having reviewed all pleadings and submissions of the parties, and there having been no objections to the Application filed, the Court finds as follows:

1. The Receiver's attorneys, Gungoll, Jackson, Collins, Box & Devoll, P.C. ("Attorneys"), have expended a considerable amount of time in performance of legal services for the Receivership Estate, and that the services have been and will continue to be beneficial to the claimants and creditors of the Estate, and will allow the Receiver to continue recovery of additional sums of money for the benefit of the parties-in-interest;
2. That there are ample funds on hand in the Receiver's small business checking and/or treasury fund account from which interim attorney fees and costs may be paid and that it would be just and equitable to allow an interim payment to be made at this time; and
3. That Receiver's Application for Authority to Pay Interim Attorney Fees should be and is hereby granted, and the Receiver is authorized to pay Attorneys the sum of \$22,975.00 as

interim attorney fees, and \$370.29 as interim costs for the period of July 1, 2010 through September 30, 2010.


IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Receiver's Application for Authority to Pay Interim Attorney Fees filed November 23, 2010 is granted and it is ordered that Gungoll, Jackson, Collins, Box & Devoll, P.C., as attorneys for the Receiver, be allowed the sum of \$22,975.00 as interim attorney fees and \$370.29 as interim costs for services performed from July 1, 2010 through September 30, 2010, and that the Receiver is authorized to pay such fees and costs immediately.

IT IS FURTHER ORDERED that such interim fees and costs shall not be regarded as full compensation for the services rendered by the Receiver's Attorneys in this matter, but shall apply against the final amount of attorney fees and costs awarded the Receiver and his Attorneys at the conclusion of this proceeding.
