ORDER RELATING TO INTERIM DISBURSEMENTS
FROM RECEIVERSHIP ASSETS TO INTERVENOR
CHRISTIANA K. ROARK

This matter came on for hearing before this Court on December 4, 2009, on an *Emergency Application for Order Regarding Disbursement of Necessary Expenses and Reasonable Attorney's Fees for Intervenor With Court Approval* (Application). The Oklahoma Department of Securities appeared by and through its attorneys of records, Jennifer Shaw and Amanda Cornmesser. The Receiver appeared by and through his attorney of record, Bradley E. Davenport of Gungoll, Jackson, Collins, Box & Devoll, P.C. Intervenor Christiana K. Roark appeared by and through her counsel of record, Clell I. Cunningham III.

Based upon the briefs filed, the arguments of counsel, and the agreement of the parties, this Court finds as follows:

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that for the period beginning December 1, 2009 through January 31, 2010, a monthly disbursement of

\$500.00 will be paid to Intervenor C. Roark by the Receiver from the Receivership Assets.


IT IS HEREBY FURTHER ORDERED, ADJUDGED AND DECREED that a monthly distribution in the amount of \$1,500.00 shall be paid to the attorney of Intervenor C. Roark from the Receivership Assets. The attorney for Intervenor C. Roark shall have the opportunity to file monthly interim applications for additional costs incurred.

IT IS HEREBY FURTHER ORDERED, ADJUDGED AND DECREED that a one time disbursement in the amount of \$10,000.00 shall be paid by the Receiver to Intervenor C. Roark from Receivership Assets, to be used in part for funeral and medical expenses.


