**ORDER GRANTING MOTION FOR SUMMARY JUDGMENT AND
PERMANENT INJUNCTION AND ORDER OF RESTITUTION
AGAINST DEFENDANTS BOTHWELL CONSULTING, LLC
AND LAWRENCE G. BOTHWELL**

This matter came before this Court on the 11th day of February, 2010, before the undersigned Judge of the District Court in and for Oklahoma County, State of Oklahoma, on the *Plaintiff's Motion for Summary Judgment Against Defendants Bothwell Consulting, LLC and Lawrence G. Bothwell* (Motion).

The Court, having reviewed all pleadings and evidence, finds in favor of the Plaintiff on their Motion. The Court finds that the debentures offered and sold by Defendants Bothwell Consulting, LLC and Lawrence G. Bothwell are securities under the Oklahoma Uniform

Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2003). The Court further finds cause to grant the Motion and, therefore:

IT IS HEREBY ORDERED that a permanent injunction be and is hereby entered forever enjoining and restraining Defendants Bothwell Consulting, LLC and Lawrence G. Bothwell from offering and/or selling securities in and/or from the state of Oklahoma.


IT IS FURTHER ORDERED that Defendants Bothwell Consulting, LLC and Lawrence G. Bothwell pay restitution to all investors who purchased debentures from any of the Defendants in this case and to all investors for whom Defendants Bothwell Consulting, LLC and Lawrence G. Bothwell otherwise made investments on their behalf, and that the amount of the restitution shall be \$640,000. The amount of restitution to be paid to each such investor shall subsequently be determined by this Court.


IT IS SO ORDERED.
