**SECOND AGREED ORDER ON THE STORYBOOK DEFENDANTS'
MOTION TO SEVER**


On August 10, 2009, the Court granted the Motion to Sever filed by Storybook Properties, LLC, Storybook Investments WA, LLC, and Matthew G. Story ("Storybook Defendants"). The Oklahoma County Court Clerk's office has requested additional information in order to effectuate the Court's Order. The Court therefore orders the following:

1. Pursuant to the Order entered on August 10, 2009, the plaintiff's claims against the Storybook Defendants are severed into a separate action.
2. The Oklahoma County Court Clerk's Office shall assign this new action a different case number. This new action shall be assigned to Judge Gurich.
3. The defendants in this new action shall include Storybook Properties, LLC, Storybook Investments WA, LLC, Matthew G. Story, Joe Don Johnson, and James Farnham. The Oklahoma County Clerk's Office shall delete Storybook Properties, LLC, Storybook Investments WA, LLC, and Matthew G. Story from the caption of this case. Joe Don Johnson and James Farnham shall be defendants in both cases.
4. The Oklahoma County Court Clerk's Office shall copy and transfer the following pleadings into the case file for this new action:




