

Therefore, for the reasons set forth above, Plaintiff respectfully requests this Court enter the attached order.





ORDER

On the 1st day of May, 2015, this matter came before the undersigned Judge of the District Court in and for Oklahoma County, State of Oklahoma, upon Plaintiff's motion for summary judgment; Plaintiff's motion to strike the Defendant's additional responses to motion for summary judgment; Defendant's motion to reconsider and Plaintiff's application for attorney fees and costs. Plaintiff appeared by and through its attorneys, Amanda Cornmesser and Terra Bonnell, and Defendant appeared *pro se*. The Court, having reviewed all of the pending motions, finds that the filings made by Defendant *pro se*, before the withdrawal of his counsel of record on May 1, 2015, are inappropriate and should be stricken. The Court advised Defendant of his right to proceed *pro se* and further advised Defendant that if he chooses to proceed *pro se*, he will be held to the same standard as an attorney. Defendant stated he intended to obtain an attorney within thirty (30) days.

IT IS HEREBY ORDERED that all filings made by Defendant *pro se*, before the withdrawal of his counsel of record on May 1, 2015, are stricken. The stricken filings

include, but are not limited to, discovery requests and Defendant's Motion to Reconsider. Plaintiff's motion to strike Defendant's additional responses to motion for summary judgment is moot.

IT IS FURTHER ORDERED that this matter is stayed for thirty (30) days, or until May 31, 2015, to allow Defendant to obtain counsel. Defendant shall not make any *pro se* filings during those thirty (30) days. If Defendant has not obtained counsel by May 31, 2015, he shall file an entry of appearance *pro se* in compliance with Rule (10) of the Rules for District Courts of Oklahoma.

IT IS FURTHER ORDERED that *Plaintiff's Motion for Summary Judgment*, filed December 31, 2014, and *Plaintiff's Reply To Defendant's Response To Motion For Summary Judgment*, filed April 24, 2015, shall be combined and treated as one motion for summary judgment. Defendant is permitted to file another response to Plaintiff's motion for summary judgment on or before June 15, 2015, and provide an emailed or hand-delivered copy to Plaintiff on said day. Plaintiff may file a reply within five (5) days of Defendant's response.

IT IS FURTHER ORDERED that the hearings on Plaintiff's motion for summary judgment and Plaintiff's application for attorney fees and costs are set for July 13, 2015, at 1:30 p.m.
