
**ORDER APPROVING CONSERVATOR'S REPORT AND

NOW on this 24<sup>th</sup> day of May, 2013, the application of Conservator, Tom Moran, for entry of an Order approving the interim application for Conservator's fees and expenses for the period of December 1, 2012 through March 31, 2013, came on for consideration before the undersigned Judge. The Court having reviewed the application, being advised that Plaintiff has no objection to the granting of this application, and no objection being filed by Defendants, finds that the Conservator's Application should be granted for good cause shown. 


