After discussion among the Court and counsel and by agreement of all counsel, the Court orders as follows concerning the briefing and hearing schedule in this appeal from the Oklahoma Securities Commission:

- (1) Plaintiffs/Petitioners shall file an opening brief no later than August 17, 2015.
- (2) Defendant/Respondent shall file a response brief no later than September 17, 2015.
- (3) Plaintiffs/Petitioners, at their option, may file a reply brief no later than September 28, 2015.
- (4) Defendant/Respondent, at its option, may file a closing brief no later than October 8, 2015.

(5) The briefs enumerated in paragraphs (1) and (2) above shall not exceed 20 pages in length and the briefs enumerated in paragraphs (3) and (4) above shall not exceed 5 pages in length.


(6) The Court will hear oral argument on October 28, 2015 at 9:00 a.m.


