DEFAULT JUDGMENT AGAINST INTERGLOBAL WASTE MANAGEMENT, INC.

This matter came on for hearing this 24 day of July, 2005, before the undersigned Judge of the District Court in and for Oklahoma County, State of Oklahoma, upon the Plaintiff's Petition for Permanent Injunction and Other Equitable Relief (Petition) against InterGlobal Waste Management, Inc. (IWM).

The Court, having reviewed the Petition, summons, return of service and court file, finds that IWM has been validly served with the Petition and summons, that the date by which IWM was required to appear and defend this action was September 29, 2004, and that no appearance has been made by IWM, nor has any motion or pleading been filed on its behalf. IWM is in default and has thus admitted the allegations of the Petition.

It appears to this Court from the facts alleged in Plaintiff's Petition and being fully advised in the premises, and on consideration thereof, finds that Plaintiff is entitled to the relief for which it has prayed against IWM.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that IWM, its agents, servants, employees, assigns and all those persons, directly or indirectly, acting on their behalf, under their direction and control, and/or in active concert or participation with them be and hereby are, permanently enjoined from, directly or indirectly, offering or selling any security in and/or from this state.
