

FINAL ORDER TO CEASE AND DESIST

Pursuant to the Oklahoma Uniform Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2009), an investigation was conducted by the Oklahoma Department of Securities (Department) into the activities of Copper Canyon Developments Inc., Samarth Verma, Harold John Shields and Frances Barrick (collectively, "Respondents"), in connection with the offer and/or sale of securities in and/or from the state of Oklahoma.

On January 27, 2011, the Administrator of the Department (Administrator) issued an *Order to Cease and Desist* and *Notice of Opportunity for Hearing (Order and Notice)* against Respondents. Pursuant to Section 1-611 of the Act, service of the Order and Notice upon Respondents was effected by service upon the Administrator on January 27, 2011. Pursuant to Section 1-604 of the Act, the *Order and Notice* were mailed to Respondents at their last known addresses, by certified mail, return receipt requested, and delivery restricted, on January 27, 2011. The mail to Copper Canyon Developments, Inc. was returned marked Return to Sender, Unclaimed, Unable to Forward. The mail to Samarth Verma was returned marked "Return to Sender, Attempted - Not Known, Unable To Forward." The mail to Harold John Shields was returned marked "Returned to Sender, Undeliverable As Addressed." The mail to Frances Barrick was returned marked "Return to Sender, Attempted - Not Known" "Unable to Forward/For Review, No Forwarding Order On File, Return To Postmaster Of Original Addressee For Review."


No request for hearing has been received by the Administrator.

The Administrator, being fully advised in this matter, finds that the issuance of this Order is in the public interest and hereby adopts the Findings of Fact and Conclusions of Law set forth in the Order.

THEREFORE, pursuant to Section 1-604 of the Act, the cease and desist order issued by the Administrator against Respondents on January 27, 2011, is final by operation of law.


