**FINAL ORDER TO CEASE AND DESIST**

Pursuant to the Oklahoma Uniform Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (2011), an investigation was conducted by the Oklahoma Department of Securities (Department) into the activities of Maxim Global Republic, LLC, MGR Forex Fund and Christian G. Alvarado (collectively, "Respondents"), in connection with the offer, sale and/or purchase of securities in and/or from Oklahoma.

On October 30, 2012, the Administrator of the Department (Administrator) issued an *Order to Cease and Desist* and *Notice of Opportunity for Hearing (Order and Notice)* against Respondents. Pursuant to Section 1-611 of the Act, service of the Order and Notice upon Respondents was effected by service upon the Administrator on October 30, 2012. Pursuant to Section 1-604 of the Act, the *Order and Notice* were mailed to Respondents at their last known addresses, by certified mail, return receipt requested, and delivery restricted, on October 30, 2012. The return receipts for Maxim Global Republic, LLC, MGR Forex Fund and Christian G. Alvarado were returned marked "Return To Sender, Not Deliverable As Addressed, Unable To Forward." A second return receipt for the registered agent of Maxim Global Republic, LLC was signed on November 6, 2012. On November 2, 2012, the United States Postal Service attempted to deliver the Order and Notice to a second address for Christian G. Alvarado and left a notice.


No request for hearing has been received by the Administrator.

The Administrator, being fully advised in this matter, finds that the issuance of this Order is in the public interest and hereby adopts the Findings of Fact and Conclusions of Law set forth in the Order and Notice.

**THEREFORE**, pursuant to Section 1-604 of the Act, the cease and desist order issued by the Administrator against Respondents on October 30, 2012, is final by operation of law.


