MOTION TO WITHDRAW AS COUNSEL

1. Kane Russell Coleman & Logan PC (the "Firm"), by and through Kenneth W. Biermacher, appeared and answered and answered in the captioned matter on behalf of CleanSip 2000, Inc., Donna M. Andrew and Robert E. Hodgins (collectively, "Respondents").

2. Mr. Biermacher has not moved to represent the Respondents *pro hac vice*. Rather, Mr. Biermacher agreed to file the appearance and answer on behalf of Respondents with the understanding that Respondents would engage Oklahoma counsel to represent them in these proceedings, assuming the proceedings were not immediately dismissed.

3. Mr. Biermacher has been informed by Rebecca Cryer, enforcement attorney for the Oklahoma Department of Securities (the "Department"), that the matter is going to be set for hearing on the merits.

4. The Firm and Mr. Respondents hereby move for an order granting their withdrawal from the representation of Respondents. In this regard, the Firm and Mr. Biermacher request that the Department inform respondents of the pendency of this request for withdrawal of counsel and, upon granting the relief sought herein, further provide that the Respondents have a period of at least thirty (30) days time within which to have new counsel appear on their behalf.

WHEREFORE, Kane Russell Coleman & Logan PC, by and through Kenneth W. Biermacher, hereby requests that the Department of Securities permit the withdrawal of the Firm and Mr. Biermacher from representation of the Respondents and, upon notice to the Respondents, order that they have thirty (30) days after the entry of the order, or such other reasonable period of time as determined by the Department, within which to have new counsel appear to represent the, and for such other further relief as is appropriate and necessary.


