**ORDER GRANTING DEPARTMENT'S
MOTION FOR LEAVE TO SUPPLEMENT RECOMMENDATION**

WHEREAS, on April 29, 2014, the Enforcement Division of the Oklahoma Department of Securities (Department) submitted to the Administrator of the Department (Administrator) an *Enforcement Division Recommendation* (Recommendation) in support of the imposition of sanctions on Jim J. Hammons (Respondent), pursuant to Section 1-411 of the Oklahoma Uniform Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (2011), for violations of Sections 1-501 and 1-502 of the Act and 660:11-7-42 of the Rules of the Oklahoma Securities Commission and the Administrator of the Oklahoma Department of Securities (Rules), Okla. Admin. Code §§ 660:1-1-1 through 660:25-7-1.

WHEREAS, on September 23, 2014, the Enforcement Division filed *Department's Motion for Leave to Supplement Recommendation* (Motion) and served the Motion on counsel for Respondent by email and U.S. Mail in accordance with paragraph 9 of the *Amended Scheduling Order* issued in this matter on September 8, 2014.

WHEREAS, under the *Amended Scheduling Order* and 660:2-9-3(c)(2) of the Rules, Respondent had ten (10) days after service of the Motion to file a response to the Motion.

WHEREAS, ten (10) days has passed since the Motion was served on Respondent, and Respondent has not filed a response to the Motion.

Upon review of the Motion, the Administrator finds good cause exists for granting such Motion.

NOW THEREFORE, IT IS HEREBY ORDERED that the Motion is granted and the Enforcement Division may file the *Supplemental Recommendation* attached to the Motion.

IT IS FURTHER ORDERED that Respondent may file a response to the *Supplemental Recommendation* within fifteen (15) days after service of the *Supplemental Recommendation* upon his counsel.


