ORDER SETTING HEARING

The Administrator of the Oklahoma Department of Securities ("Administrator" and "Department") issues this Order under 660:2-9-2 of the Rules of the Oklahoma Securities Commission and the Administrator of the Oklahoma Department of Securities ("Rules"), Okla. Admin. Code §§ 660:1-1-1 through 660:25-7-1, and Section 1-411 of the Oklahoma Uniform Securities Act of 2004 ("Act"), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (2011).

On August 18, 2015, the Enforcement Division of the Department filed an *Enforcement Division Recommendation* ("Recommendation") with the Administrator in support of the imposition of sanctions on Anthony Ray Stacy ("Stacy") and PVPE, LLC ("PVPE") (collectively, "Respondents"), pursuant to Section 1-411 of the Act, for conduct violating the Act and Rules as set forth in the Recommendation.

On August 21, 2015, the Administrator issued a *Notice of Opportunity for Hearing* ("Notice") and a *Notice of Service on the Administrator and Affidavit of Compliance* ("Affidavit"). On the same date, copies of the Affidavit and the Notice, with a copy of the Recommendation attached to the Notice, were sent by certified mail, return receipt requested, delivery restricted to addressee, to the last known addresses of Respondents, in compliance with Section 1-611 of the Act.


On August 25, 2015, service of the Notice, Affidavit and Recommendation on PVPE became effective. PVPE did not file an answer to the Recommendation and did not request a hearing. A final order relating to PVPE was issued on September 25, 2015.

On September 14, 2015, service of the Notice, Affidavit and Recommendation on Stacy became effective. Stacy filed an answer to the Recommendation on September 29, 2015, and a request for hearing on October 5, 2015.

NOW THEREFORE, IT IS HEREBY ORDERED that a hearing shall commence at **9:00 a.m.** on **February 3, 2016**, in the offices of the Oklahoma Department of Securities located at 204 North Robinson Avenue, Suite 400, Oklahoma City, Oklahoma. At such time, opportunity shall be afforded all parties to respond and present evidence and argument on all issues involved.
