ORDER OF TEMPORARY INJUNCTION

This matter came on for hearing this 23rd day of January, 1998, before the undersigned Judge of the District Court in and for Oklahoma County, State of Oklahoma upon the motion of the Plaintiff for a temporary injunction against Randall D. Jeffers pursuant to Section 814.A.2. of the Oklahoma Business Opportunity Sales Act ("Act"), Okla. Stat. tit. 71, § 801-827, (1991 & Supp. 1997). Plaintiff appears by and through its attorney of record, Mark S. Edmondson. Defendant Randall D. Jeffers did not appear.

It appears to this Court from the facts alleged in Plaintiff's verified Petition and in its motion for temporary injunction that Plaintiff is entitled to the relief for which it has prayed against Randall D. Jeffers.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Randall D. Jeffers, his employees, agents, and other individuals in active concert or participation with him who receive actual notice of this order, by personal service or otherwise, and each of them, be, and hereby are, instanter and until further notice of this Court, enjoined and restrained from:

1. the offer and sale of business opportunities from or in this state unless and until such business opportunities are registered by Randall D. Jeffers and revoke any exemption claim made by Randall D. Jeffers pursuant to the Act;

2. the offer and sale of business opportunities from or in this state unless and until a written disclosure document prepared pursuant to Section 808 of the Act is delivered to each purchaser as required by the Act; and

3. directly or indirectly omitting to state material facts necessary to make statements made, in light of the circumstances under which they were made, not misleading in connection with the offer and sale of business opportunities from or in this state.

IT IS SO ORDERED.
